The Chairperson, Jenny Weaver, addressed the meeting acknowledging the contribution from the following;

Board - Joy O'Hazy (Vice Chair), Ted A'Bear (Chair Future Directions Committee), Julie Monis-Ivett (BKFA/Zonta Engagement Committee), Fatemeh Afzali (Treasurer), Angelina Arora, Madhu Mazumdar and Bridget Mather at the early part of the year

Jenny noted that while BKFA emerged from COVID, stresses are there – cost of living especially Raising funds for BKFA has never been harder

Great contribution as a team by the staff to lower our costs and improve and work efficiently.

Board Directors have had do more work through our committee structure and have been excellent at taking on extra duties to maintain our productivity.

Observed the trends early in the year same number of ADs but production numbers down... our supporters are very keen to keep up a commitment they just cannot do as much.

BKFA has had to be creative: -

- To lower our costs Adrian worked on a sea freight option which might save us over \$40 k this financial year.
- Expanded our supporter base through Zonta Ambassadors & Champions plus ZI Convention –clubs in USA, Germany and NZ are now making kits
- Corporates getting familiar with corporate social responsibility (CSR) work brilliantly
 with international companies such as ThermoFisher and Pernod Ricard. It is a good base
 to build on and lots of potential.
- More in-country kits made possible by The Charitable Foundation locally made and employing local women building skills in our partners.

- Developed skills in our partner UACO to be a kit maker and to distribute kits this is a
 very pleasing development in building partner capacity and may prove a good template for
 the future.
- Program when no kit is available aware some of our partners have disappeared over the last few years and our production is down, so what can we offer? Still in formative stages but it is working...
- Use technology increasing using options internally Mercy uses WhatsApp to keep in touch with and meet with partners, and externally checking out options for midwives and birth attendants. There is a lot of potential here but also a lot to work through.

What has BKFA achieved?

- Over 118.000 kits delivered
- Training continues in Ethiopia and via Soul Foundation Uganda
- In-country kits make in DRC< UGANDA Ethiopia

Despite the on-going issues it has been a productive and satisfying year meeting these challenges.
